STRATTEC SECURITY CORPORATION (Nasdaq: STRT) announced today that its Board of Directors has authorized the repurchase of an additional 250,000 shares (approximately 6 percent of currently outstanding shares) under its ongoing stock repurchase program. Shares may be repurchased from time to time in open market transactions and will be held as Treasury Shares.

This latest action brings the total repurchase authorization to 2,639,395 shares, of which 2,160,026 have been repurchased to date.

STRATTEC SECURITY CORPORATION designs, develops, manufactures and markets mechanical locks, electro-mechanical locks and related access control products for North American and, through its alliance partners, select European automotive manufacturers.
